The undersigned hereby applies for FiberNET service at the location listed on this application and agrees to pay for said services as measured by the MUS's meters or equipment according to the regular schedule of rates of MUS, as may from time to time be modified. The applicant agrees to permit authorized agents of the MUS free access to the premises of the applicant (or occupant) for the purpose of installing, testing, repairing, or removing property of the MUS. Applicant represents that he or she has the authority to grant such access. The applicant agrees to be responsible for the protection of agents of the MUS from pets and animals which occupy the premises. The applicant agrees that this application is subject to the current MUS's Rules and Regulations and applicable rate schedules, a copy of which is open for inspection at the main office of the MUS and on our company website at www.musfiber.net, and that such rules and regulations are part of this agreement. In the event of default of payment of any bills or other charges arising hereunder, the undersigned agrees to timely pay MUS its costs of collection including reasonable attorney's fees. By affixing his, her or their signatures hereto, customer(s) acknowledge they have granted MUS/FiberNET permission to perform a credit identity assessment for the purpose of confirming the identity of the customer and determining the amount of any required deposit.
